The Washington State Supreme Court considered the request submitted by letter dated April 26, 2024, by the King County Department of Public Defense, the Snohomish County Office of Public Defense, the Snohomish County Public Defender Association, and Professor Paul Holland that the Court temporarily suspend, on an emergency basis, Standard 14 of CrR 3.1 and CrRLJ 3.1—Qualifications of Attorneys. The Court finds that temporary suspension of Standard 14 is warranted while the Washington State Bar Association's suggested amendments to the Court's Standards for Indigent Defense are pending before the Court.

Now, therefore, pursuant to the Court's authority to administer justice and the Court's authority to take emergency action with respect to rules pursuant to GR 9(j)(1), it is hereby ORDERED:

- (a) Standard 14 of CrR 3.1 and CrRLJ 3.1—Qualifications of Attorneys, is hereby suspended for one year from the date of this Order.
- (b) During the suspension of Standard 14 of CrR 3.1 and CrRLJ 3.1, the Certification of Appointed Counsel of Compliance With Standards Required by CrR 3.1/CrRLJ 3.1/JuCr 9.2 is modified in the form attached hereto.
  - (c) This order will be published on the Washington Courts website.
