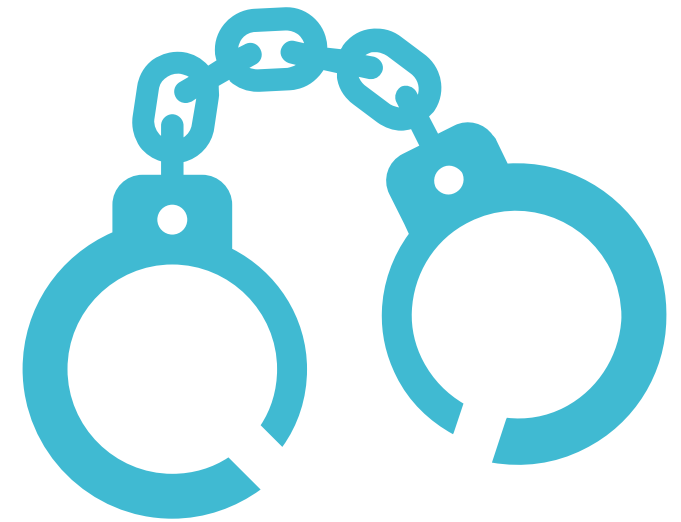

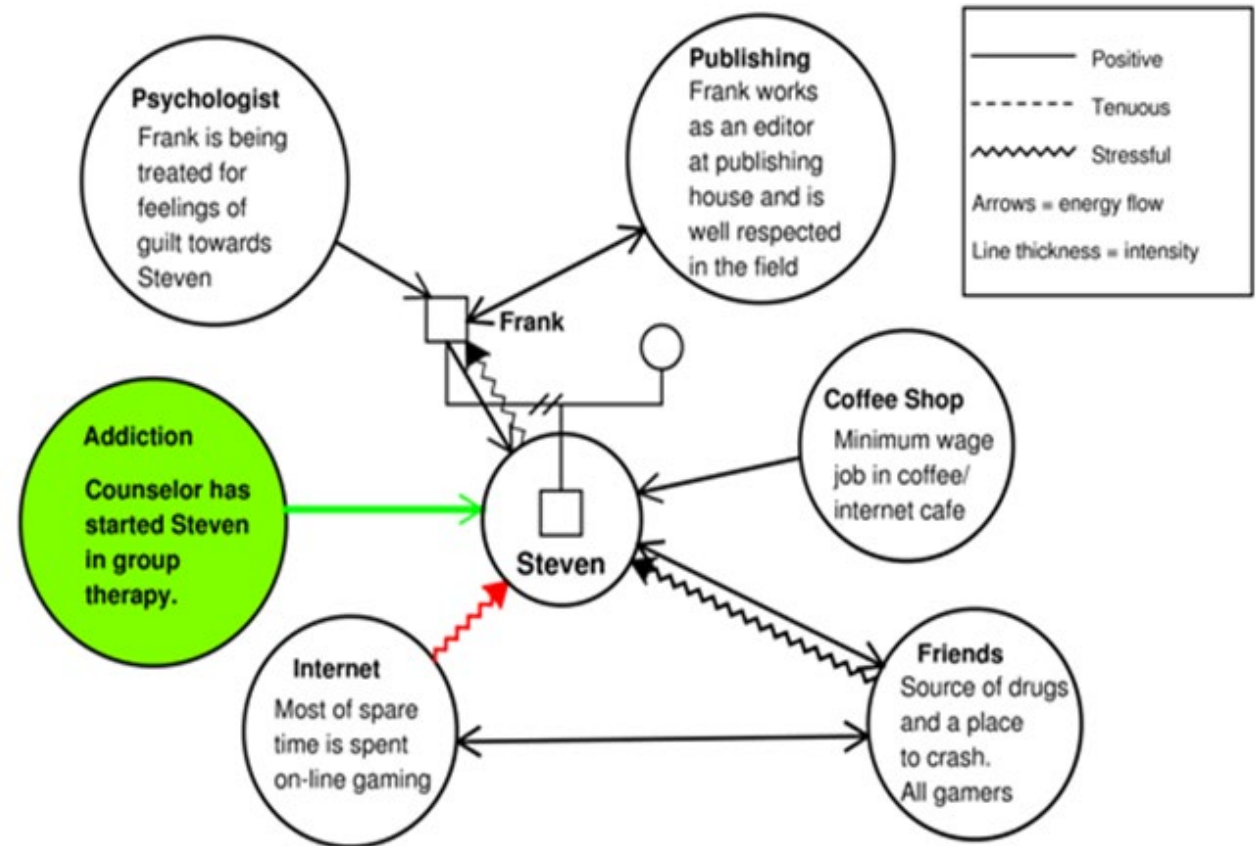

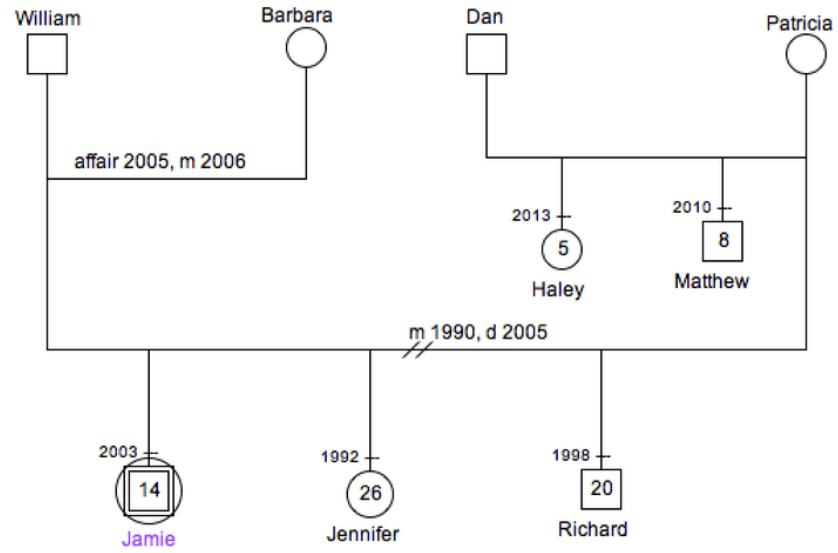

History of CDBFSW

- *-Social Work has always served vulnerable populations*
 - 1963 - *Gideon v. Wainwright* – prompted the systematic creation of public defense systems to serve indigent individuals
 - 1967 – Right to counsel for juveniles
 - 1990 – Fear of the “super predator”, summer of violence
 - 2005 – *Roper v Simmons* - developmental factors, peer influence, identity
 - 2011 – *Miller v Alabama* – *critical differences b/w adult and juvenile brain*
 - 2016 – *Graham v Florida* – *JLWop unconstitutional*
 - Steinberg – a leading researcher on adolescence*
 - Colorado model (JLWop, juveniles, direct-file, reverse-transfer)... all CDBFSW clients*
- 2019 - Criminal Defense-Based Forensic Social Work (Ratliff & Willins)

Communication is KEY!!!

- You are a team
- Attorney as the lead
- Set expectations at the beginning
- FSW as an arm of the attorney
- Client a member of the team
- Team meetings
- Check-ins (meet, email, phone)
- Re-visit expectations

Trauma- informed Care

- **Five Guiding Principals**

- Safety
- Trustworthiness
- Choice
- Collaboration
- Empowerment

How to?

- **What to DO:**
- -follow your client's pace
- -set clear goals (trustworthiness)
- -accept some resistance
- -strength's based (empowerment)
- -safety (physical, emotional, psychological)
- **What NOT to do:**
- -do not push
- -do not ignore client goals (choice)
- -do not touch
- -do not re-traumatize

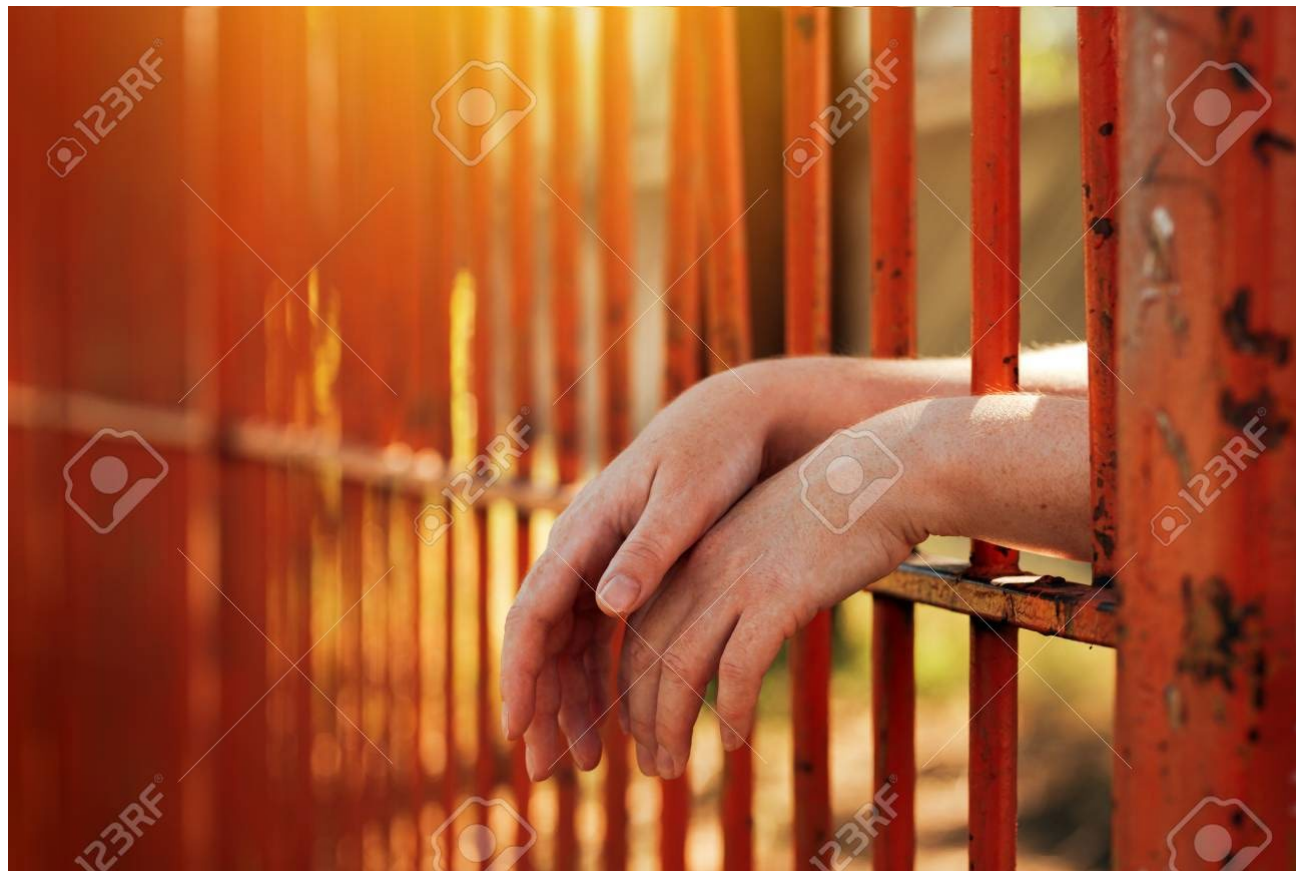

Requesting records

- A tedious task, but SO important and worth it
- Integral tool for developing and backing up your mitigation/themes
- Can be used as a visual aid in reports
- Experts typically require comprehensive records



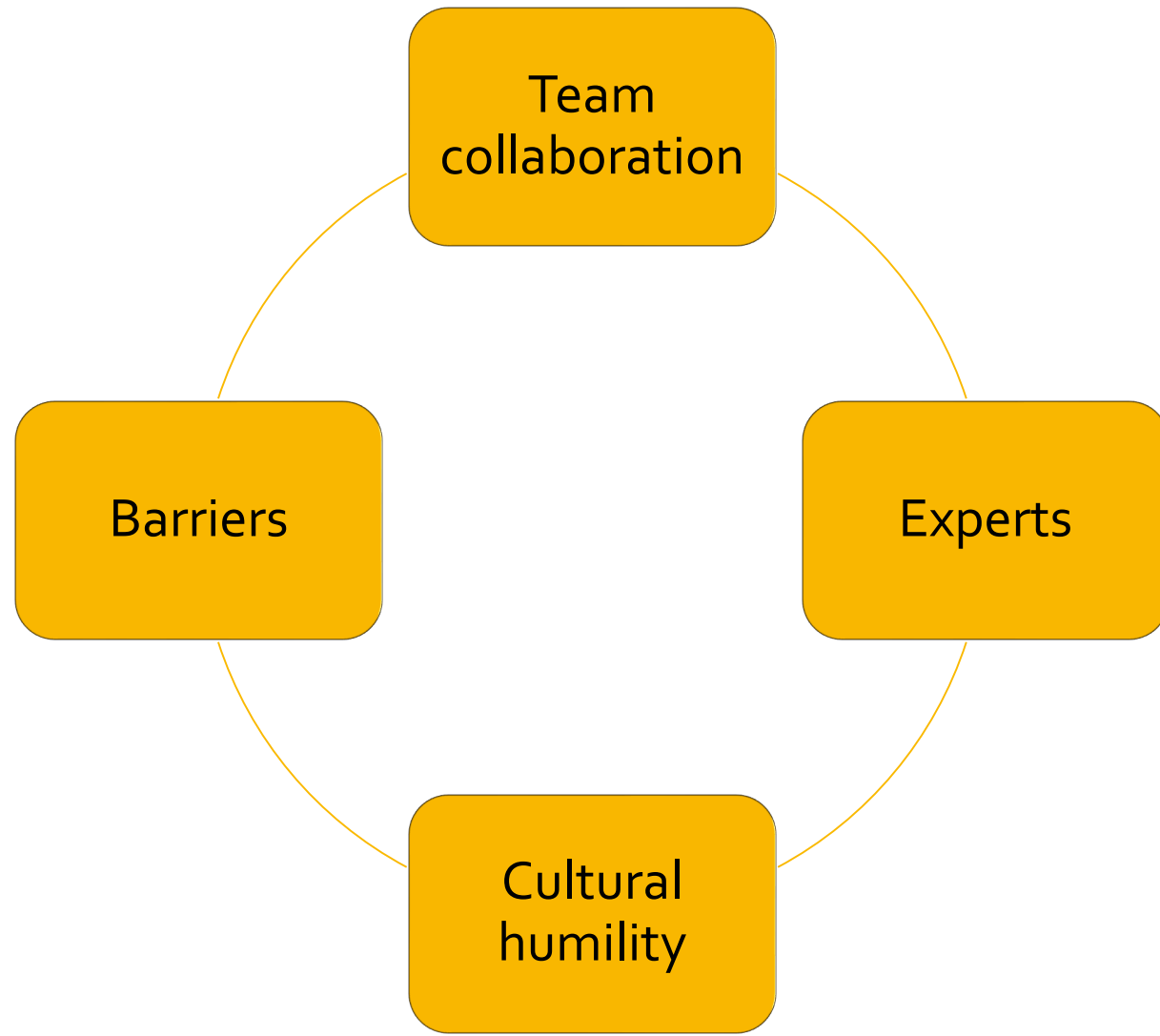
Common Sources of Records

- Birth records
 - These typically require the mother's consent
- Medical: pediatrician, psychiatric hospitals, emergency room, etc.
- Child Welfare
- Education
 - Request the student file from the last school attended
 - Special education: IEP and 504 documents come from the district
- DSHS
 - Department of Developmental Disabilities (DDA)
 - State children's psych hospitals (ex: CSTC)
- Mental Health records
- Juvenile Justice related
 - Youth detention records
 - Juvenile probation

Washington Practice Tips

- Health Care authority: if your client is not a good historian, you can request a “health care ledger” that will give you a list of places state Medicaid was billed. For example, hospitals, ERs, community mental health agencies, etc.
- Department of Children Youth & Families (DCYF): statewide system (also how you request records from Juvenile Rehabilitation). These records are extremely slow and take 6+ months to receive
- Practice tips:
 - DCYF requires a client ID be submitted along with the ROI. In lieu of ID, DCYF will take alternative forms. - You can let them know your client is in custody and unable to provide ID, and write a declaration, submit a jail booking photo, or write a letter of representation and attach the notice of appearance.
 - Try to be specific as possible. The narrower the request, the quicker you will get records
 - If you do not need the complete CPS file, you can ask for a “prior involvement report.” This will give an overview of involvement and investigations, but is no where a complete record. Best used in time crunch scenarios
