On May 21, 2025, Governor Bob Ferguson signed into law the state's operating budget (ESSB 5167), marking a historic milestone for Washington's public defense system. This budget includes the first substantial increase to the Office of Public Defense's (OPD) Public Defense Improvement grant program since 2008 and the largest increase since the program's inception.

Previously funded at approximately \$6.8 million annually, the Public Defense Improvement Program now has \$13.6 million in annual disbursements to counties and cities. Under the new budget, counties will receive \$11,910,500 annually, while cities will receive \$1,689,500—significantly increasing the previous allocations of \$5,821,675 and \$1,043,275, respectively. Estimated county disbursements can be found below. Cities are welcome and encouraged to apply for funds for public defense improvements in their jurisdictions

OPD expresses its deep appreciation to the Legislature and Governor Ferguson for recognizing the growing challenges within the state's public defense systems. Amid significant budget constraints, this increase represents a crucial step toward improving access to adequate legal defense for indigent individuals across Washington. However, OPD acknowledges that more work remains to fully address the ongoing deficiencies in public defense.

During the legislative session, OPD had requested that Public Defense Improvement funding be raised to \$40 million annually to meet the critical needs of public defense systems statewide. While pleased with the increased investment, OPD remains committed to advocating for continued and additional funding in future legislative sessions to ensure public defense resources align with growing workloads and rising costs.

Public Defense Improvement grants are available to qualifying cities and counties as supplemental funding to bolster existing public defense budgets. To qualify, jurisdictions must submit applications to OPD detailing their public defense expenditures, caseload numbers, and efforts to meet Washington State Bar Association Standards for Indigent Defense – or show that funds are used to make appreciable, demonstrable improvements in the delivery of public defense services.

Applications for Public Defense Improvement grant funding for counties and cities will be available in early June. Applications will be posted at Chapter 10.101 RCW County and City Public Defense Improvement Funds | Office of Public Defense
